Subject: Extension of the period of Accreditation status granted to PG Engineering programs, National Institute of Technology Karnataka, Surathkal, Srinivasnagar, Mangalore-575025, Karnataka from 5 years to 6 years.

Sir,

This has reference to NBA's letters of even number dated 11/04/2017 and 08/06/2017 under which PG Engineering programs offered by your Institution were granted accreditation for 5 years up to 30-06-2022 in Tier-I by National Board of Accreditation.

2. National Board of Accreditation has decided that in all cases where PG Engineering programs of an Institution were granted accreditation for a period of 5 years in Tier-I/Tier II in January 2013 Document, the period of accreditation of these program(s) shall be extended from 5 to 6 years subject to the condition that they meet the Pre-qualifiers. The Pre-qualifiers submitted by **National Institute of Technology Karnataka, Surathkal, Srinivasnagar, Mangalore-575025, Karnataka** in respect of the following PG Engineering programs for extension of duration of accreditation from 5 years to 6 years have been considered in NBA. The programs meet all the parameters of pre-qualifiers. Accordingly, the Competent Authority in NBA has approved the following accreditation status to the programs as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted extension of duration of accreditation from 5 to 6 years. **National Institute of Technology Karnataka, Surathkal, Srinivasnagar, Mangalore-575025, Karnataka** is requested to apply afresh for accreditation of the programs in the new May 2017 SAR Document.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **National Institute of Technology Karnataka, Surathkal, Srinivasnagar, Mangalore-575025, Karnataka** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

7. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
